- V. Correction and Approval of Minutes of 10 Dec 2015
 - There were several corrections to the minutes as listed below.
 - Garcia seconded the motion to approve the Dec minutes.
 - The information about the meeting with members of the Walnut Hills Scholarship Committee was missing most of the information: Fuller told the WHCA that the Scholarship Committee board was not ok with the stipulation we wanted to impose to have the scholarship recipients have to be members of the WHCA.  letter to Planning that we are not taking a stand on this beyond the technical comments we've already sent in but, to indicate the pros and cons that we've heard from
 residents and board members and urge the Planning & Zoning Commission to

- b. Sidewalk on S Xanthia St, Bern
 - A motion was made, seconded, and passed with one negative vote (Senn) to allow the WHGID to pay the total bill for the project, not to exceed \$30K, if they can do it as part of the current construction project. JG/BB
 - The WHCA Board would like the City to pick up some small part of the bill to show a
 partnership with Walnut Hills.
- c. Movie Night, Ferrin
 - Ferrin says the plans for the event are final and distributed a schedule for the event. He asked that we go from 3-5 pm.
 - The school has the necessary AV equipment and we can rent if for \$15. We will plan
 to use Gamec's laptop from which to project. Fazal will bring a small DVD player as a
 backup to the school equipment.
