Our wonderful GID project manager, Maggie Haskett has resigned after almost 6 years of pulling weeds, planting flowers, hauling water, picking up trash, hanging holiday wreaths, dealing with contractors and taking care of anything else that is required to keep our neighborhood looking great. The 'What' and 'Why' of the Walnut Hills Civic Association

The Walnut Hills Civic Association was formed in 1965 to serve our community. Our mission statement includes three primary goals:

Preserve the quality of our neighborhood: What does this mean? Several things - Walnut Hills has a General Improvement District (GID). This is funded by a small levy in your annual taxes. The GID is responsible for the perimeter, keeping the perimeter of our neighborhood looking good - this has been done flawlessly by our GID Project Manager, Maggie Haskett for the last 6 years. Great neighborhood events. These events are organized to promote community. Events range from Dumpster Days to Movie Night and this year a new event with the Disk Golf tournament. These events are a great opportunity to get out, meet your neighbors, say hello to the board members and discuss and share what is important to the residents here. Community Support. We work hard to support our neighborhood organizations, clubs and groups - including the young adults in our neighborhood with the Walnut Hills Scholarship. Much of this support is not possible without the generosity of our residents through dues and scholarship contributions.

Keep the community informed on issues that impact us: The Walnut Hills Civic Association has several different avenues to distribute information to the community - News blasts, our website, the Walnut Hills Newsletter, and just recently Next Door. We try very hard to give our neighbors the information that they want and need about events in the neighborhood and in our larger community.

Advocate for the community's position with state and local government: Our responsibility also extends to coordinating with local and state governments and agencies on the community's position, issues of concern and to maintain an open line of communication. If ever you are curious about what is going on, in Walnut Hills or in our larger Centennial community, don't hesitate to ask! Chances are, the board members can either answer your questions, or direct you to someone who can.

All of these things take time, and many of them take funds. We currently have a board consisting of 14 members from all areas of the neighborhood and all walks of life. These people bring many different ideas and values - some days we are on the same page - some days we have some very heated discussions about agenda items. We try to satisfy all of the concerns and issues that are brought up by the residents to the best of our ability.

For the most part, we utilize all of the funds that we collect through dues (\$25 annually). Several of our events - dumpster days specifically - are very expensive. This year alone, the WHCA board paid almost \$3,500 for just the electronic recycling. We are happy to host and pay for these events - but we can't do it without your support! A very heartfelt THANK YOU to all of our paid members - you make this possible - and a very hopeful CAN YOU? to our non-members - the \$25 annual dues are well used and all go back directly to the community. Dues are good from March through February and get you one free dump at spring and fall dumpster days as well as eligibility for holiday light contest prizes.

If you don't currently participate, consider it. Our neighborhood is a great place to live, work, raise a family, walk a dog, ride a bike or any of the other activities that occur daily. WHCA has even entered the 21st Century (albeit with a push) and dues can be paid online with PayPal. We still accept all the old fashioned methods too....

The Easter Bunny is on His Way!

Just a quick save the date: The annual Easter Egg Hunt will be held on Saturday, April 8th at 11:00 am. We will be again holding it at the Walnut Hills Park (same place as Fourth of July, not the school). We will have four areas for the kiddos - less than 3 years old, 4-6 years old, 7-9 years old and 10+ - bring the kids, the dog, grandma and grandpa, etc. and enjoy our (hopefully) beautiful morning! Should a snow date be required, we will meet at 11:00 the following Saturday. The Easter Bunny has put us on his busy schedule and will be available for pictures and to enjoy the festivities. We will also have several art tables going throughout the course of the event. Please join us. As always, this event is paid for with the dues collected so please fill out your membership form during the March membership drive for the 2017 year. 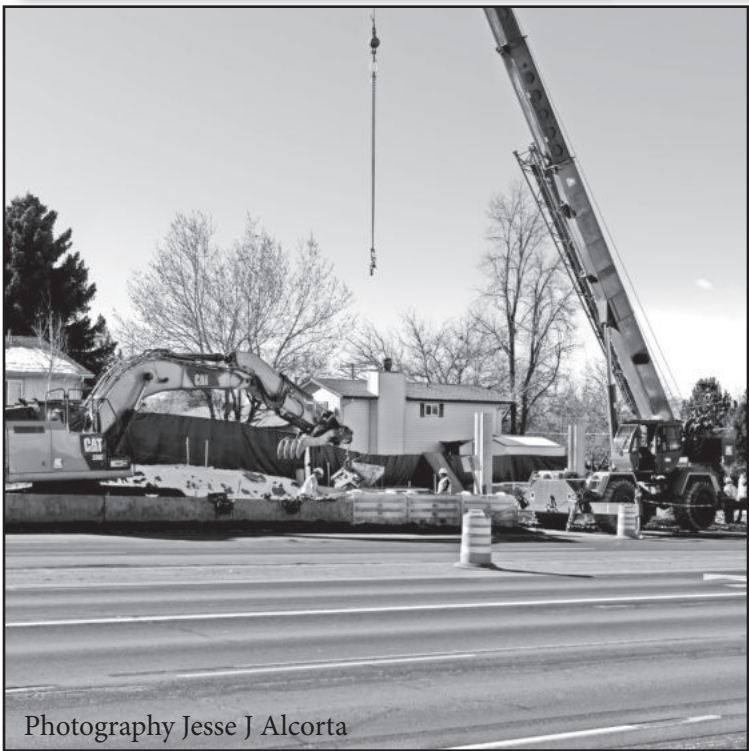

An Update on the I-25 Arapahoe Interchange Reconstruction Project

Construction continues in full force through the winter months on the I-25 and Arapahoe Interchange Reconstruction project, and a lot progress will be made this spring. Phase three I-25 bridge construction will require overnight lane closures due to a deck pour in early February. Plans this spring include realignment and construction of eastbound lanes on Arapahoe Road. Also, in the upcoming months, work will continue on noise walls along Arapahoe Road and Yosemite Street as well as a retaining wall on the south side of Arapahoe Road. This project is scheduled for completion in summer 2018.

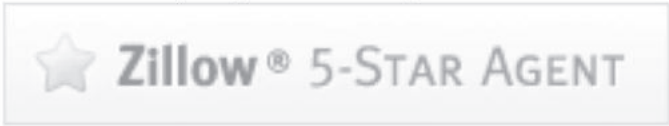

Vehicles Parked in the Rights-of-Way (Streets)

Centennial has just passed an ordinance (law) that puts some more limits on which vehicles may park on neighborhood streets. If some of this doesn't make sense, you may contact me for a copy of the whole ordinance or contact your City Councilmen for more clarity. I'll just quote here from the ordinance #2017-O-01. First, some definitions and then what can go where.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF CENTENNIAL, COLORADO, ORDAINS:

Section 1. Subsection (15) of Section 8-1-30 of the Centennial Municipal Code is repealed and reenacted to read as follows in its entirety:

1212. Parking restrictions for recreational vehicles, trailers and commercial vehicles.

(b) Camper means non-wheeled, detachable vehicular equipment that weighs over five hundred (500) pounds, used for temporary or permanent habitation, which has no independent motor power and that is capable of being placed on a vehicle but is not capable of being towed.

(c) Camping Trailer means a trailer constructed to provide temporary occupancy as a dwelling or sleeping place for one or more persons, to include, without limitation, "fifth wheels."

(h) Motor Home means a motorized vehicle designed to provide temporary occupancy as a dwelling or sleeping place for one or more persons and which is intended to be transported upon streets and highways, but excluding pick-up trucks with attached campers.

(k) Recreational Vehicle or RV means a motor home or camping trailer and does not include campers or mobile homes.

(l) Recreational Trailer means a trailer used and operated for any purpose other than a predominantly commercial purpose, such as a boat trailer or snowmobile trailer.

(p) Trailer means any wheeled vehicle without motor power that may be drawn over the roadway by a motor vehicle, including camping trailers, utility trailers and boat trailers.

(2) The following restrictions shall apply to parking vehicles on public rights of way in residential districts anywhere within the boundaries of the City of Centennial:

(a) No recreational vehicle (RV) or trailer, whether or not attached to a motorized vehicle, or camper unattached to a motor vehicle, or boat unattached to a recreational trailer, or mobile home shall be parked on any public street or highway within any residential district of the City, with the exception of:

1. A recreational vehicle (RV) or trailer if:

(A) It is parked only for a period that does not in any event exceed forty-eight (48) consecutive hours, and

(B) The recreational vehicle (RV) or trailer is parked immediately adjacent to and on the same side of the street as the property occupied permanently by the registered owner of such recreational vehicle (RV) or trailer, and

(C) A new up to forty-eight (48) hour period allowed by subsection (A) is never initiated without an intervening minimum twenty-four (24) hour period from the conclusion of the previous up-to-forty- eight (48) hour period, during which time the recreational vehicle (RV) or trailer must be removed from and remain off the street, and

(D) No part of the recreational vehicle (RV) or trailer, or any part of any item placed thereon, is on or over the sidewalk, including, without limitation, tires, and no slide outs or awnings or other protrusions from the recreational vehicle (RV) or trailer are in the open position, and no cords, wires, hoses or other appurtenances from such recreational vehicle (RV) or trailer, including any item placed thereon, are laid upon or across the sidewalks or rights-of-way, and

(E) There are no tarps or vehicle covers placed upon such recreational vehicle (RV) or trailer, except that a custom- fitted boat or recreational trailer cover or shrink wrap which is secured around the entire perimeter of the boat or recreational trailer is permitted.

2. A recreational vehicle (RV) parked immediately adjacent to and on same side of the street as a residential lot for up to forty-eight (48) hours when and if the registered owner of such vehicle is temporarily visiting the permanent occupant of such residential lot. A new up to forty-eight (48) hour period allowed by this subsection shall not be initiated without an intervening minimum twenty-four (24) hour period from the conclusion of the previous up to forty-eight (48) hour period, during which time the recreational vehicle (RV) must be removed from and remain off the street. Any vehicle parked in accordance with this subsection shall not be occupied or used as a sleeping quarters or for other housekeeping purposes

3. Any vehicle otherwise parked in violation of this section for a period not to exceed four hours (4) as a result of an emergency.

(b) Subject to the further restrictions set forth in subsection (c) below, no commercial vehicle shall be parked upon any public street located in a residential district except temporarily for such period of time necessary to expeditiously complete rendering services to real property located within two hundred (200) feet of the commercial vehicle.

(c) No semi-tractor, truck, semi-trailer or bus shall be parked upon any public street located in a residential district other than when being loaded and/or unloaded or otherwise rendering services within two hundred (200) feet of the commercial vehicle, and such loading and/or unloading or rendering of service shall only occur between the hours of 7:00 am and 7:00 pm. No loading and/or unloading of a semi-tractor, truck or semi-trailer during permissible hours is allowed to extend over more than two consecutive calendar days.

Section 3. Section 12-2-404(B)(3)(e), concerning Home-Based Business Standards is hereby repealed and replaced to read as follows:

(e) Parking of commercial vehicles in violation of Section 12-5-403.

Section 4. A new section 12-5-403, entitled "Commercial Vehicle Parking Restrictions in Residential Zone Districts" shall be added to Article 5 of the LDC to read in its entirety as follows:

Sec. 12-5-403 Commercial Vehicle Parking Restrictions in Residential Zone Districts.

A. Generally. Parking of commercial vehicles on residential property shall be limited because it is inconsistent with the nature of that use of property.

B. Restrictions. No commercial vehicle shall be parked upon any private property in a residential district outside of an enclosed garage except temporarily for such period of time necessary to expeditiously complete rendering services to the property.

C. Exceptions. This prohibition shall not apply in residential districts zoned agricultural (AG) or neighborhood conservation (NC2a) so long as the commercial vehicle is parked more than fifty (50) feet from any residential structure located on an adjacent property.


